It was granted under a permitted development and had to be completed within 5 years. They didn't complete within 5 years due to medical reasons. Last year DNP contacted them and advised them to apply for full planning permission.

Cllr Willett asked about battery lightening – he answered yes this is correct, LED light, no mains. No electricity and no plans to use so. Even if he did it would be a generator not mains.

The applicant added there is to be a screening hedge using saplings Cllr Parker asked what saplings is he proposing to use, he answered hazel, ash and hawthorn - all quite mature and ready to go when he has permission.

Please note we considered this at our January Planning Meeting and supported the proposal. "Hennock Parish Council don't object to the conversion of the barn to a holiday let. We are pleased to see the mitigations put in place for birds and bats. We do have concerns as for the need for a reception and information office if it's only one holiday let."

11. Progress reports from the Clerk for information and consideration:

11.1. Motorhomes at the Claycutter Arms, Chudleigh Knighton

The Clerk was asked to investigate at the last planning committee meeting whether regulations were being adhered to regarding motorhomes and the disposal of their waste. Cllr Sueref read out the email from the Clerk that had been circulated to all councillors 06/07/21. "I spoke to the Landlord yesterday on the phone and he said they do allow and welcome Motorhomes but don't provide any additional facilities i.e. toilets, showers, washing up space



etc. I specifically asked him if they allow the emptying of chemical toilets and he said "No". If anyone asked for this facility he would recommend Oakmoor, Dunley who charge £5 for this facility."

11.2. The County of Devon (Footpath no.8 (Hennock) public path diversion order.

We considered the informal consultation at our January planning meeting and supported the proposal.

To note the Clerk has received correspondence from the Open Spaces Society with the following comments "Having considered the matter further and inspected the site of the proposed diversion, I have told the Parks Authority that the Opens Spaces Society neither opposes nor supports the making of the Diversion Order. In other words we are taking a neutral stance. It does not seem to me that any users of the right of way will be inconvenienced by the slight change of route." This was noted.

11.3. Drainage Issues regarding 1 Stokelake, Chudleigh 21/00976/HOU

See email sent 19/07/21 by the Clerk that includes the Officer Report which addresses drainage issues. This was noted.

12. To consider Draft Teignbridge Local Plan (Part 2) 2020 - 2040

There was a long discussion regarding the leaflet drop and drop in event. The residents comments written on post it notes at the Drop In sessions had been distributed to councillors prior to the meeting and had been categorised along with a draft report.

These are the salient points from the discussions during the meeting:

- A couple of supporting comments from the consultation for the housing sites but mainly negative. However, for the employment use site it was pretty much all negative.
- Main concern is for all the land to stay as exception sites. And can therefore legitimately fight for social housing.
- For all three sites, we wish to say that a junction going to Exeter from the other side of the village which would alleviate the pressure of traffic coming through the village and this should be explored.
- As a village the number of homes we think the village can support is a maximum of 45 homes

It was agreed that all comments and discussion to be written up in a separate response to the local plan and signed off by the clerk, chairman of the planning committee and chairperson of the parish council for submission before 9th August. [SEE APPENDIX A]
