Although Hennock Parish Council does encourage and support recycling, we do have some concerns on the issues that the environmental risk assessment has highlighted namely emissions of dust, odour, litter and noise, plus the potential increase of lorries on neighbouring roads. All of these are issues that historically Hennock Parish Council has received complaints about. We would like to see air quality monitored and further receptors installed including in Chudleigh Knighton.

Our Response: Hennock Parish Council considered proposal 18/02070/FUL on 27<sup>th</sup> November 2018. The parish council objects to this application on the grounds of the impact on the foul water/sewage system which is inadequate. The application does not take into account the larger units at 40&41 (planning application ref: 18/02042/FUL) and the parish council considers the proposed density will result in overcrowding in this part of the site.

Cllr Janette Parker said she has received lots of complaints from residents regarding the lorries that have been arriving in the village at 7.45am / 7.50am and parking up as they are not allowed on site until 9am. She has spoken to the Site Manager about this and he promised to speak to their contractors, but the situation hasn't changed. In addition, lorries are going through the western side of the village which is very narrow. Cllr Chris Applewood said he has written twice to Tom Biddle of Baker Estates regarding the Biodiversity Policy that he discussed with him at the Annual Parish Meeting of the and he has yet to have a response.

The Clerk informed the meeting that on 17<sup>th</sup> May she had met with National Grid, the Chairman of CKAA and the plot holder at Chudleigh Knighton Allotments for a site visit to discuss the erection of a temporary pole on the western edge of the top allotment, this will enable power to be maintained for much longer. Some residents may have a short power cut and National Grid will send letters to those affected.

The road closure scheduled for 12<sup>th</sup> August – 6<sup>th</sup> September was noted to divert the water mains.
