The Parish Council feels very strongly that Town and Parish Council representatives should continue to be invited to planning site inspections because they can add value by contributing from local knowledge. Whilst the Council accepts that the Parish Council representative must only report the Parish Council's views and Teignbridge District Council will have received written observations from the Parish Council, there is often much more in terms of discussion which has led to the decision and which is not always included in the written response/observations - these views of the Parish Council, conveyed in the context of a discussion/questions at a site visit, can make an important contribution to the overall planning process.

The answer is not to exclude but to train and Hennock Parish Council urges Teignbridge District Council to reconsider this decision and, instead, train Parish/Town councillors in this process so that complaints from members of the public are avoided in the future and the integrity of the planning system in terms of openness and transparency is retained.
